INSPIRE LEARNING YOUR CHILD AND THEIR iPad

The Scottish Borders Council (SBC) Inspire Learning programme will see every young person from P6-S6 get an iPad and a range of digital learning tools and resources.

This will help and enhance their learning at school and:

- Raise educational attainment
- Provide equality of opportunity for all pupils
- Create a pupil centred curriculum which will provide engaging pupil-centred lessons
- Enable children and young people access to the most up to date educational resources
- Raise levels of engagement, motivation and interaction
- Improve facilitation of different learning styles
- Support remote and/or independent learning
- Improve self-management
- Improve the digital skills needed for the future workplace.



The Council and school will have full supervision of all iPads used in school and in particular:

- The Council retains ownership of all apps.
- The Council will manage all iPad devices using a Mobile Device Management (MDM) system.
- The Council will provide all required components to ensure the iPad operates effectively in the classroom, including Wi-Fi access.
- The Council maintains the right to filter and monitor Internet content and manage the use and connection of iPad to the school network.

When the iPad is being returned to the school either for replacement or because the young person is leaving the school, the iPad, the case, an original Apple charger and any cables should be returned together. The iPad can be returned with or without its original box.

SBC will have full supervision of the device through the school's MDM system. This will include the ability to install applications, software, documents, eBooks onto the device, manage software updates and turn on/off different features as may be required.

If a young person leaves the school their iPad must be returned.

TAKING CARE OF THE iPad

Pupils are responsible for the general care of their iPad. Ones that are broken or fail to work properly must be reported to a teacher.

iPads must never be left unattended or in any unsupervised area. They should also be kept in the pupil's possession at break and lunchtime. They can leave them in their locker if they have one during lunch or breaks.

The protective case provided is really robust and must be used with the iPad at all times.

We ask that your child avoids placing too much pressure or weight (such as folders and workbooks) on the iPad screen as they can be sensitive to damage from too much pressure.

USING iPad AT SCHOOL

Pupils will be using their iPad at school each day. In addition to using it for lessons; school messages, announcements, planners, calendars and schedules may be accessed using the iPad. Therefore, we are asking pupils to come to school every day with their iPad fully charged and ready to go.

Please note, iPads should be brought home at night and charged. They shouldn't be left in the school overnight unless by prior arrangement, e.g. maintenance purposes, or if this an arrangement with the school.

Pupils should not lend or share their allocated iPad with other pupils unless asked to do so by a teacher in class.

If pupils leave their iPad at home, they are responsible for getting any assignments or coursework completed as if they had their iPad with them. Spare iPads won't be available to students who forget to bring their one to school or who haven't charged it.

USING iPADS AT HOME

Pupils will be able to enjoy the benefits of using their devices for educational purposes at home, with or without Wi-Fi access.

We are asking you to monitor and oversee your child's use of their iPad at home.

Family members can make use of the device and the pre-loaded educational apps. Internet filtering would continue to apply at home, however that would still allow access to many internet services. Parents and young people will not be able to download any apps onto the device.

Please note, when used outside of school, for example on home broadband or public internet connections, internet access will still be filtered and monitored by SBC systems.



MANAGING FILES AND SAVING WORK

Students are responsible for ensuring their work is not lost due to technical issues or because something was deleted accidentally. Pupils should make sure they back up their work on a regular basis.

ORIGINALLY INSTALLED SOFTWARE

The Council will provide software on iPads necessary for schoolwork. The software and apps originally installed by the Council must remain on the iPad in usable condition and be easily accessible at all times.

From time to time we might add or modify software applications for use in a particular course.

INSPECTION

We might ask pupils from time to time to provide their iPad for inspection. This is just to ensure they are complying with the Acceptable Use of Computers / Internet Policy.

PROCEDURE FOR RELOADING SOFTWARE

If technical difficulties occur or illegal software is discovered, the iPad will be restored to the default factory settings. The Council does not accept responsibility for the loss of any software or documents deleted due to a re-format and re-image.

iPAD IDENTIFICATION

As all pupils will have an iPad, and to avoid any confusion, the school will make sure each one is individually labelled.

They can also be identified in the following ways:

- Serial Number also known as the mobile device management system ID
- The Council may enforce the enabling of Location Services on iPads in order to use the 'Find My iPad' app. This will only be used as a security measure to minimise loss or theft.

SAFETY AND SECURITY

The Council has invested in a Mobile Device Management system which allows us to do simple things like send out apps and files automatically, to reset passcodes, update software and set restrictions to ensure iPads, when in school, work in accordance with the acceptable use policy. Importantly, it allows the Council to protect the data on the iPad, so in the case of the iPad being lost or stolen it can be locked, wiped, tracked and traced.
